Ren Ci Hospital is seeking Service Providers to deliver on-site Linen Leasing and Laundry Services across all four facilities

RCCH provides rehabilitative care for post-acute patients, long-term care for individuals with multiple chronic conditions and reduced functional abilities and operates a Senior Care Centre (SCC). It has a capacity of 241 inpatient beds and serves up to 60 SCC day-care clients.

AMKNH, BBNH, and WNH offer day care, rehabilitation, and residential care services to lower-income patients and clients.

- AMKNH: 472 residential beds and SCC capacity for 100 day-care clients
- BBNH: 256 residential beds and SCC capacity for 60 day-care clients
- WNH: 50 palliative care beds, 332 residential beds, SCC capacity for 100 day-care clients

The Linen Leasing and Laundry Services will commence on 01 November 2026 for an initial contract term of twenty-four (24) months, with an option to extend for a further twenty-four (24) months plus an additional twelve (12) months.

#### Pre-qualification criteria

Service Providers who meet the pre-qualification criteria below will be shortlisted to participate in the RFP.

##### a) For RCCH:

- Service Providers must have a minimum of five (5) years of recent experience, providing similar services to at least one hospital facility (such as a Community Hospital or an Acute Hospital), and must indicate the client's name along with the duration of service.
- Service Providers shall possess a minimum of bizSAFE Level 3 certification to qualify for participation in this engagement.

##### b) For NHs:

- Service Providers must have a minimum of five (5) years of recent experience, providing similar services to at least one residential care or hospital facility (such as a Nursing Home, Community Hospital or an Acute Hospital), and must indicate the client's name along with the duration of service.

- ii. Service Providers shall possess a minimum of bizSAFE Level 3 certification to qualify for participation in this engagement.
